Academic Standing Policy April 26, 2012 - - Approved: May 2, 2012

All students shall demonstrate their ability to do college level work. The University requires a minimum cumulative Grade Point Average (GPA) of 2.0 to be eligible for a Bachelors degree. Any student with a cumulative GPA of 2.0 shall be considered in Good Standing by the University (some programs may have additional GPA requirements). Students who fall below the required 2.0 shall be placed on academic discipline. The 3 categories of academic discipline are as follows:

Academic Warning:

Students shall be placed on Academic Warning the first semester their cumulative GPA falls below a 2.0. Students on Academic Warning shall be allowed to register for a maximum of 15 credits and shall register prior to the first day of the semester.

Academic Probation:

Students who are on Academic Warning and fail to raise their cumulative GPA to a minimum 2.0 shall be placed on Academic Probation. Students on Probation shall be allowed to register for a maximum of 14 credits and shall register prior to the first day of the semester.

Students on Academic Probation shall remain on probation provided their semester GPA is at least a 2.3. Once the cumulative GPA reaches a 2.0 the student shall be taken off Academic Probation and be placed in Good Standing. Students shall have three (3) semesters to bring their cumulative GPA to a 2.0. If the cumulative GPA is below 2.0 after the third semester of probation, the student shall be automatically dismissed.

Academic Dismissal:

Any student of Academic Probation whose semester GPA is below a 2.3 and has a cumulative GPA below a 2.0 shall be Academically Dismissed. Students who are academically dismissed from Southern Connecticut State University shall take the subsequent semester off and appeal for reinstatement through the Academic Standing Committee. Students shall appeal during the semester they are out for the following semester. Students shall be allowed appeal to the Academic Standing Committee for reinstatement only once.

Academic Standing Policy

Any student with a cumulative GPA of 2.0 shall be considered in Good Standing by the university (some programs may have additional GPA requirements). Students who fall below the required 2.0 shall be placed on academic discipline. The three categories of academic discipline are:

Academic Warning:

Students shall be placed on Academic Warning the first semester in which their cumulative GPA falls below 2.0. Students on Academic Warning shall be allowed to register for a maximum of 15 credits and shall register prior to the first day of the semester.

Academic Probation:

Students who are on Academic Warning and fail to raise their cumulative GPA to a minimum 2.0 in the following semester shall be placed on Academic Probation. Students on probation shall be allowed to register for a maximum of 14 credits and shall register prior to the first day of the semester.

Students on Academic Probation shall be allowed to continue at the university but shall remain on probation provided their semester GPA is at least 2.3. Once the cumulative GPA reaches 2.0, the student shall be removed from Academic Probation and shall be placed in Good Standing. Students shall have three (3) semesters to raise their cumulative GPA to 2.0. If the cumulative GPA is below 2.0 after the third semester of probation, the student shall be academically dismissed.

Academic Dismissal:

Students on Academic Probation shall be Academically Dismissed if (1) their semester GPA is below a 2.3 and cumulative GPA is below a 2.0, or (2) their cumulative GPA remains below 2.0 after the third semester of probation. Students who are academically dismissed from Southern Connecticut State University shall not be allowed to register for the subsequent semester. If students choose to appeal for reinstatement, they may do so during or subsequent to the semester in which they are off. All appeals shall be made to the Academic Standing Committee. Students shall be permitted to appeal for reinstatement only once.
